General advice

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

Store in a cool and ventilated warehouse. The warehouse temperature should not exceed 2-8 ° C. It should be stored separately from oxidants and edible chemicals, and should not be mixed (see Part 10 for prohibited substances). Keep container sealed. Keep away from kindling and heat source. The warehouse must be installed with lightning protection equipment. The exhaust system shall be equipped with a grounding device to conduct static electricity. Explosion proof lighting and ventilation shall be adopted. It is prohibited to use equipment and tools that are easy to generate sparks.
